

‘Newspaper Cikagos Aidas’ mobile application privacy policy

This Privacy Policy of the ‘Newspaper Cikagos Aidas’ application (hereinafter referred to as - Policy) applies to all information that Ethnic Media LLC may have learned about the user while using this application. The user’s consent to provide personal information that they have given in accordance with this Policy as part of the relationship with one of Ethnic Media LLC employees applies to all persons who are members of Ethnic Media LLC.

Use of the application signifies the user's unconditional consent to this Policy and the conditions for processing their personal information specified therein; in case if you do not agree with these terms and conditions, the user should refrain from using the application.

1. Personal information of users received and processed by the ‘Newspaper Cikagos Aidas’ application

1.1 For the purposes of this Policy, ‘user's personal information’ shall be understood to mean:

1.1.1 Personal information that the User provides about themselves when registering (creating an account) or while using the application, including personal data of the user. The information is provided by the user at their discretion.

1.1.2 Data that is automatically transmitted by Ethnic Media LLC during the use through the application installed on the device, including information from cookies, information about the user's device.

1.2 This Policy applies only to the ‘Newspaper Cikagos Aidas’ application of Ethnic Media LLC. The Company has no control over and is not responsible for any third-party information that may be accessed via links in the application. Such websites may collect or request other personal information from the user and may also perform other activities.

1.3. Ethnic Media LLC generally does not verify the accuracy of personal information provided by users and does not control their legal capacity. However, Ethnic Media LLC assumes that the information provided to it by users is accurate and up to date.

2. Purposes of collecting and processing personal information of the user

2.1 The application collects and stores only those personal data that are necessary to provide the services included in the application.

2.2 Ethnic Media LLC may use the personal information of the application user for the following purposes:

2.2.1 Identification of a party under agreements;

2.2.2 Provision of personalized services to the user;

2.2.3. Communication with the User, including sending notifications, requests, and information related to the use of the Services, provision of services, as well as the processing of the following information requests and requests from the user;

2.2.4. Improve the quality of the application, its usability, and development of new services;

2.2.5. Conducting statistical and other studies based on anonymized data.

3. Terms of processing user's personal information and its transmission to third parties

3.1. The ‘Newspaper Cikagos Aidas’ application stores personal information of users under the Ethnic Media LLC portal rules.

3.2. Regarding the user's personal information, its confidentiality is saved, except in cases of voluntary submission of the information by the user for sharing with an unlimited number of people.

3.3 Ethnic Media LLC may transfer the user's personal information to third parties in the following cases:

3.3.1 The user has expressed their consent to such actions;

3.3.2 The transfer is necessary within the framework of the user's use of a certain service or to provide the service to the user;

3.3.3 The transfer is stipulated by the US or other applicable legislation within the framework of the procedure established by the legislation;

3.4 Ethnic Media LLC is guided by the U.S. Federal Data Privacy Law when processing personal data of the ‘Newspaper 7 days’ application users.

4. Change of personal information by the user

4.1 The user may change or update personal information by contacting Ethnic Media LLC.

4.2 The user may also delete the personal information they have provided under a particular account by requesting the deletion of their account through Ethnic Media LLC by e-mailing a request to info@ethnicmedia.us.

5.5. Measures applied to protect user's personal information

Ethnic Media LLC takes necessary and sufficient organizational and technical measures to protect user's personal information from illegal or accidental access, destruction, modification, blocking, copying, distribution, as well as from other illegal actions by third parties.

6. Change of Privacy Policy. Applicable law

6.1 Ethnic Media LLC may change this Privacy Policy. When changes are made to the current version, the date of the last update is specified. The new version of the Policy shall take effect from the moment of its posting unless otherwise specified in the new version of the Policy. 6.2 U.S. law shall apply to this Policy and the relationship between the user and Ethnic Media LLC arising from the application of the Privacy Policy.
